Girls will participate in arts and crafts, field trips, interacting with special guests, and much more. Events emphasizing sports and athletic development include volleyball, basketball, track and field, soccer, and softball. A study period is staffed each day with counselors and volunteers. The After School Program runs during the regular Alachua County Public School year calendar.**

This curriculum allows Girls Place to provide a well rounded experience for the girls. Participants do not have to commit to the entire summer; they may participate anywhere from one to ten weeks.**
